Pursuant to the terms of the grant, shares of KLA common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA common stock as reported on July 31, 2025.
2. The number of shares of KLA common stock includes 2,206,000 shares issuable upon vesting of RSUs.
